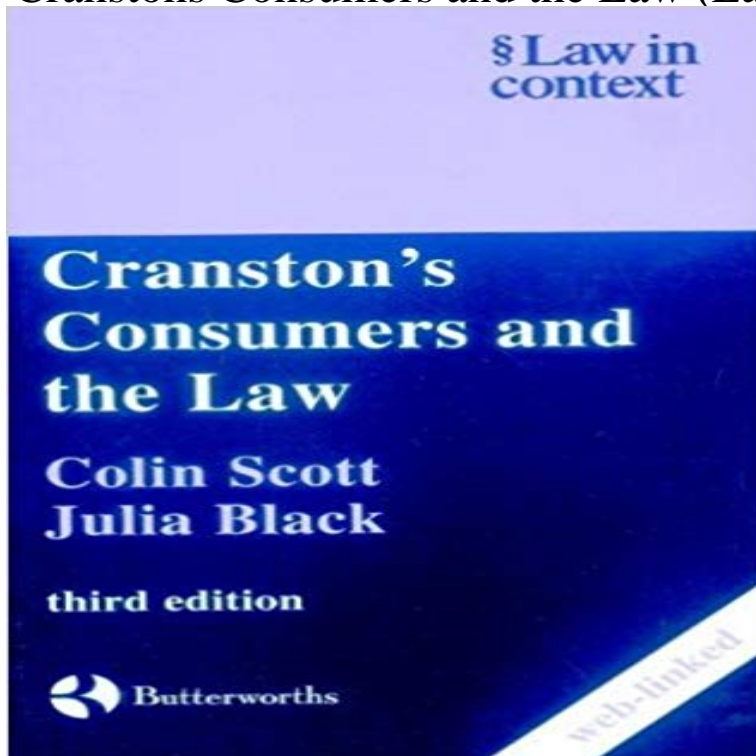


Cranstons Consumers and the Law (Law in Context)
