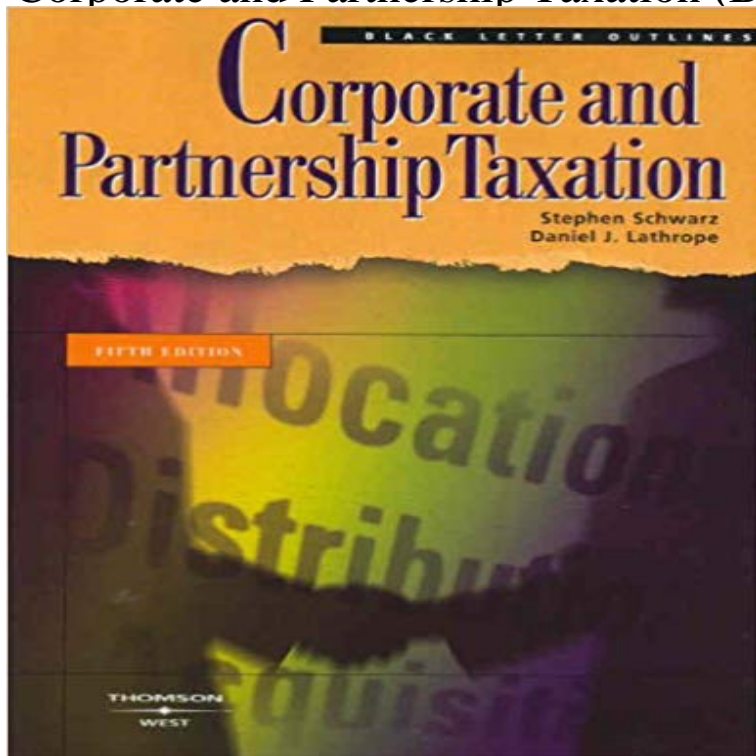


## Corporate and Partnership Taxation (Black Letter Outlines)
