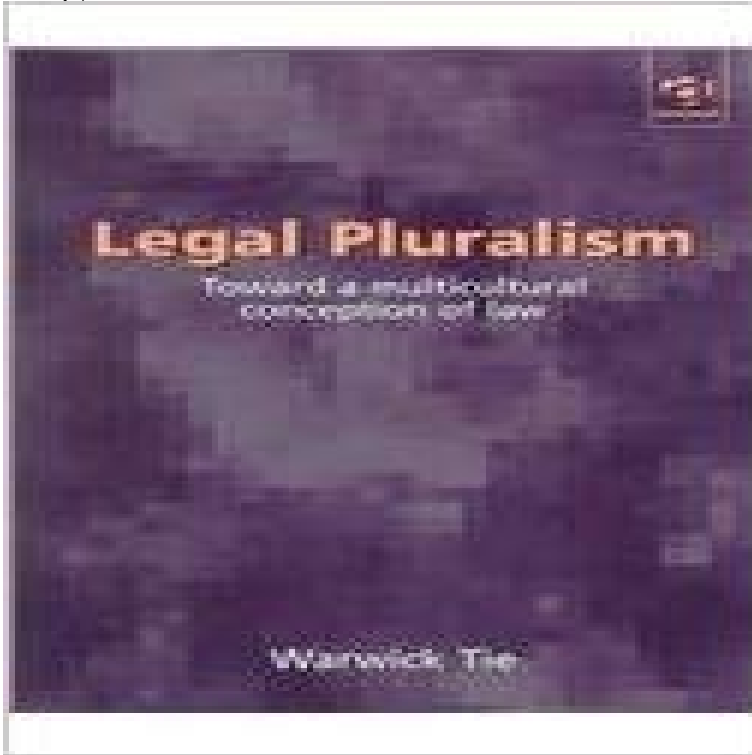


# Legal Pluralism: Toward a Multicultural Conception of Law
