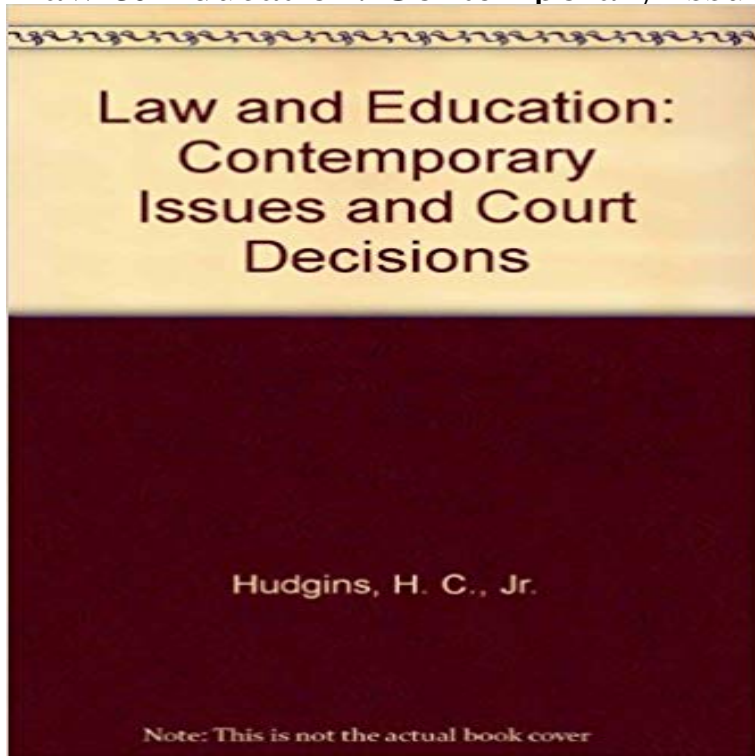


## Law & Education: Contemporary Issues & Court Decisions
