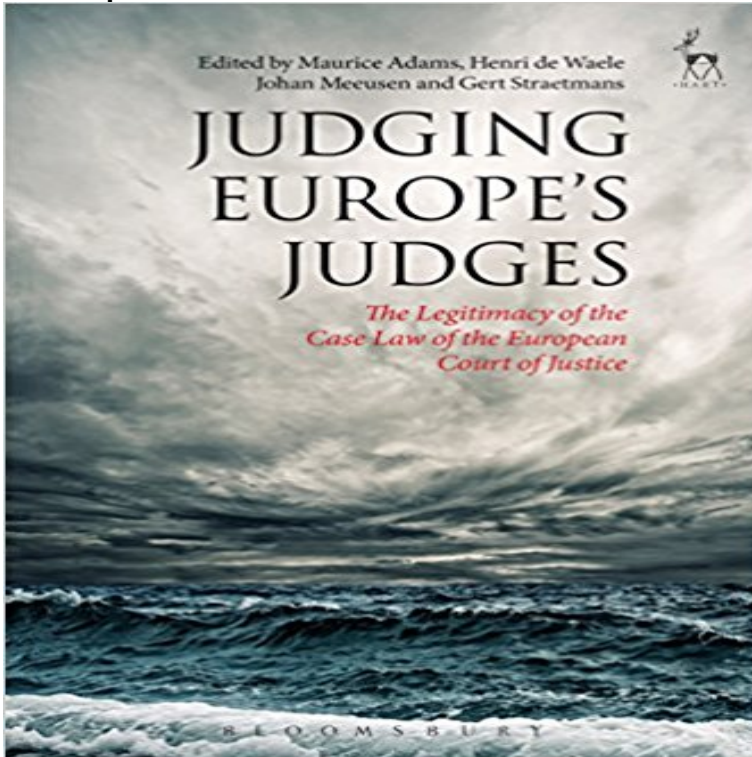


Judging Europe's Judges: The Legitimacy of the Case Law of the European Court of Justice

In doing so, specific attention is paid to its most recent case law on four topics: the general principles of EU law, external relations, the internal market, and EU citizenship.
