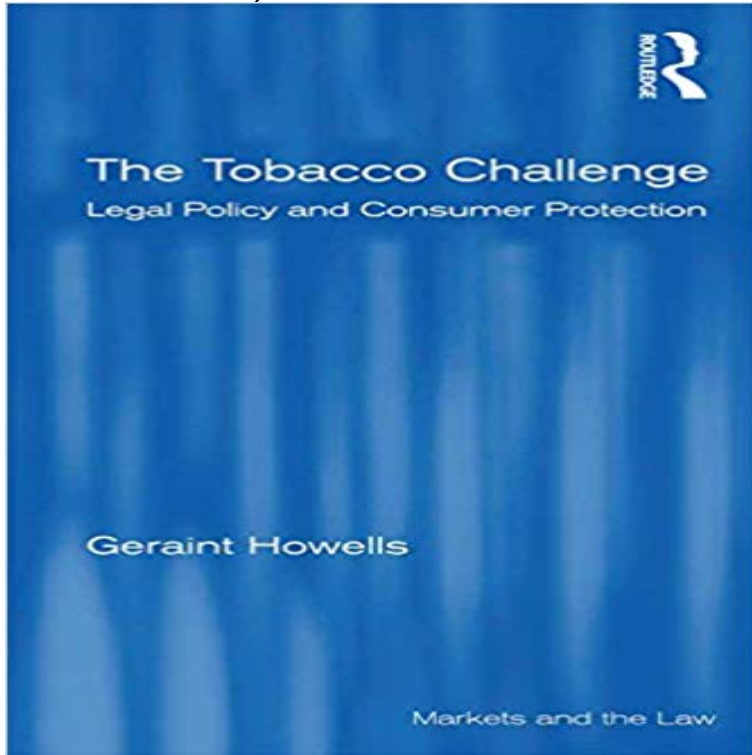


The Tobacco Challenge: Legal Policy and Consumer Protection (Markets and the Law)
