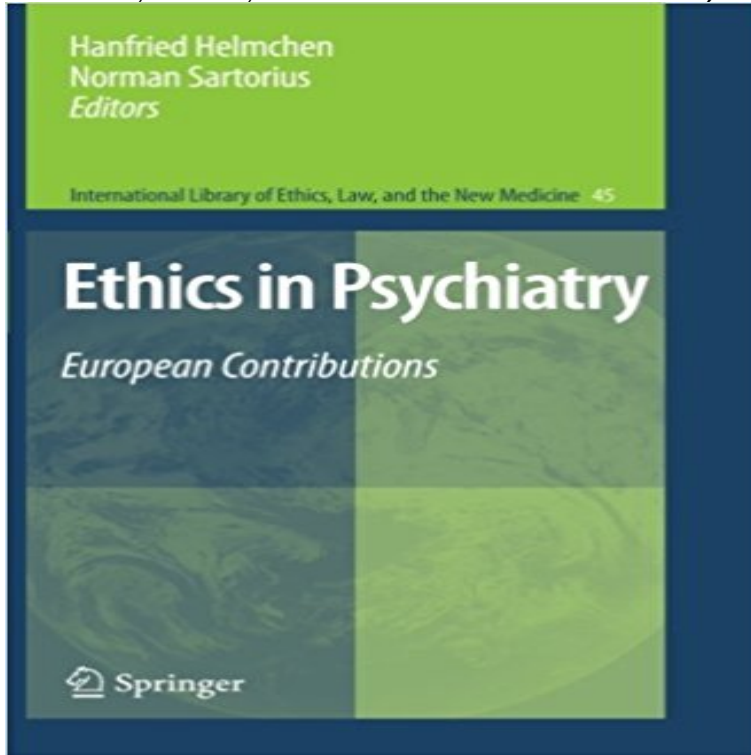


# Ethics in Psychiatry: European Contributions (International Library of Ethics, Law, and the New Medicine)
