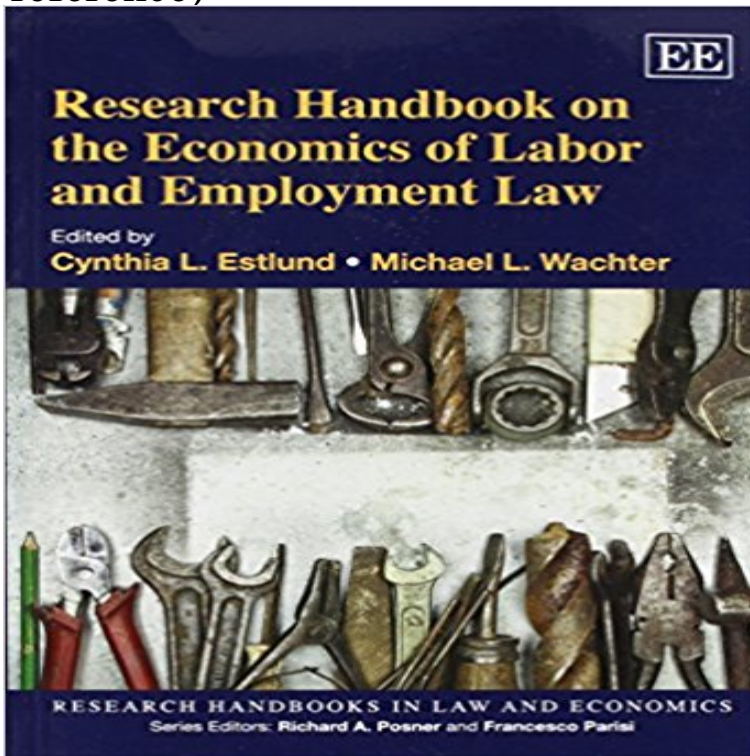


# Research Handbook on the Economics of Labor and Employment Law (Research Handbooks in Law and Economics Series) (Elgar Original reference)
