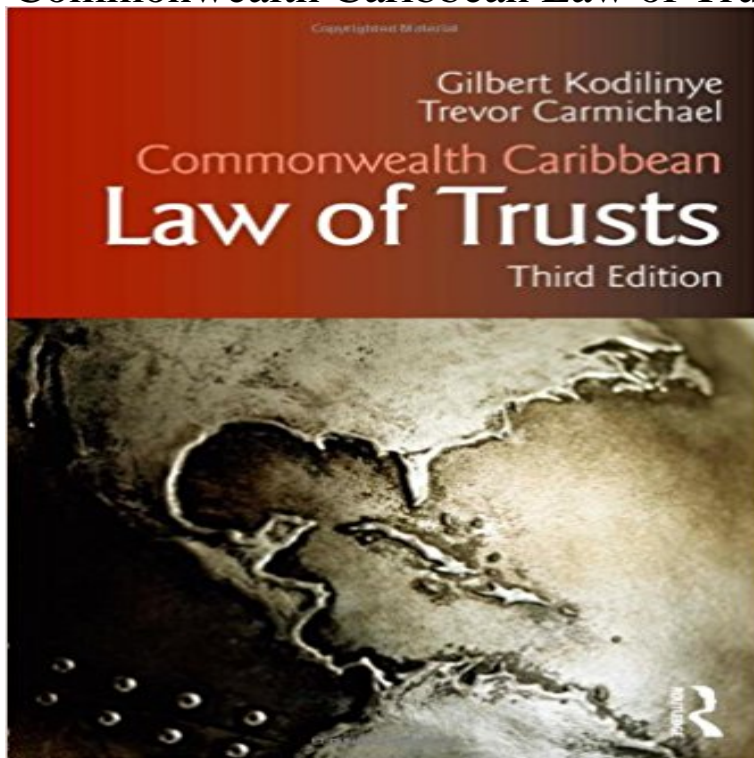


Commonwealth Caribbean Law of Trusts: Third Edition
