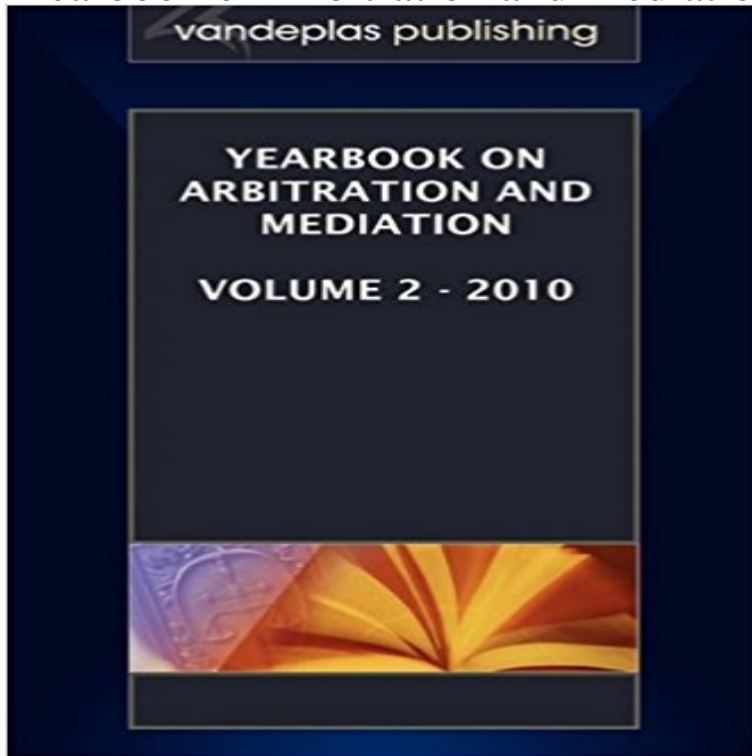


Yearbook on Arbitration and Mediation, Volume 2 - 2010
