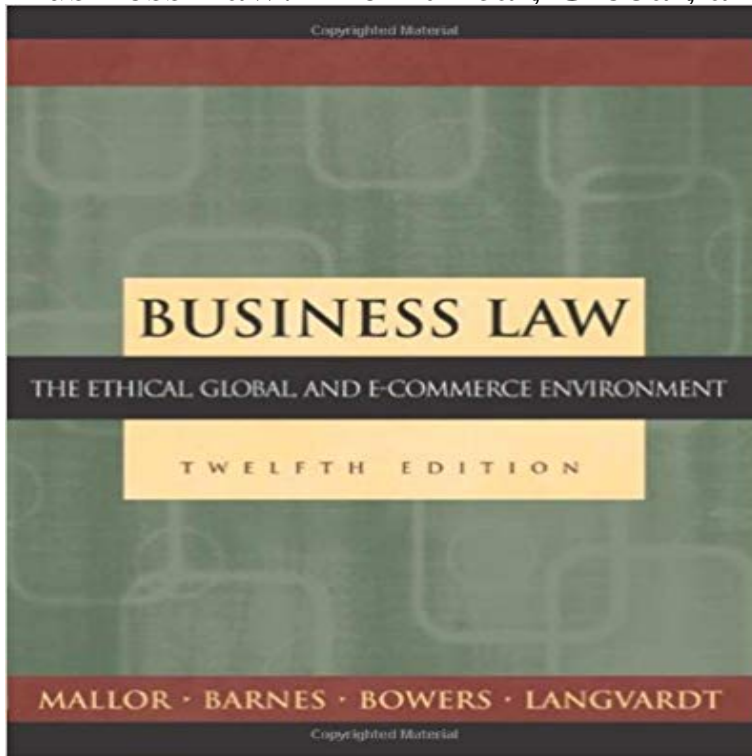


# Business Law: The Ethical, Global, and E-Commerce Environment
