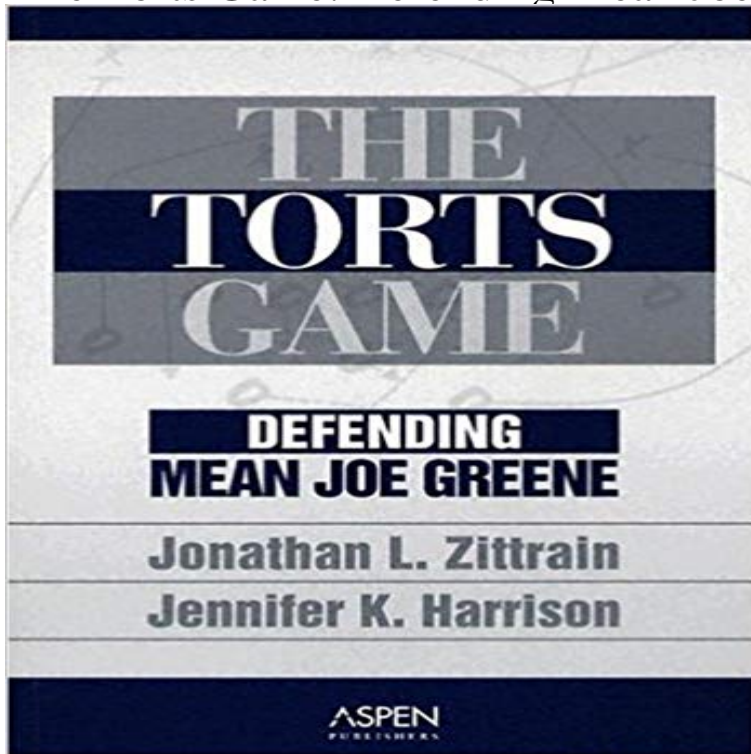


The Torts Game: Defending Mean Joe Greene
