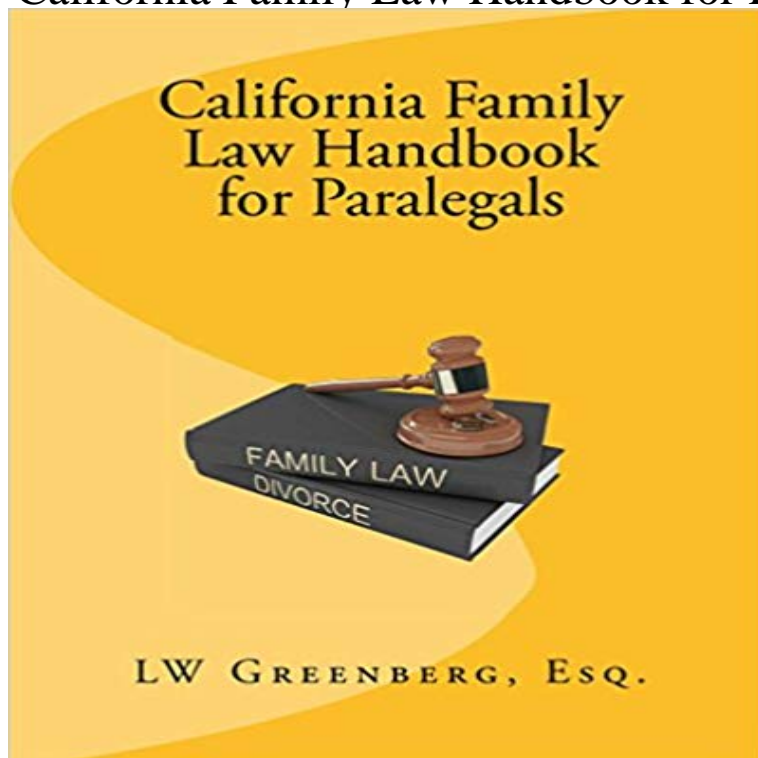


## California Family Law Handbook for Paralegals
