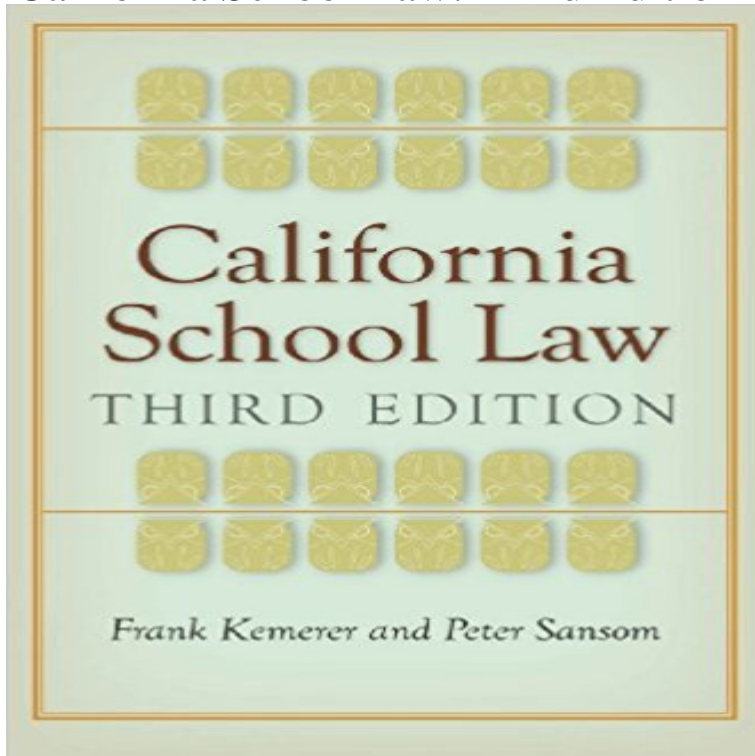


## California School Law: Third Edition
