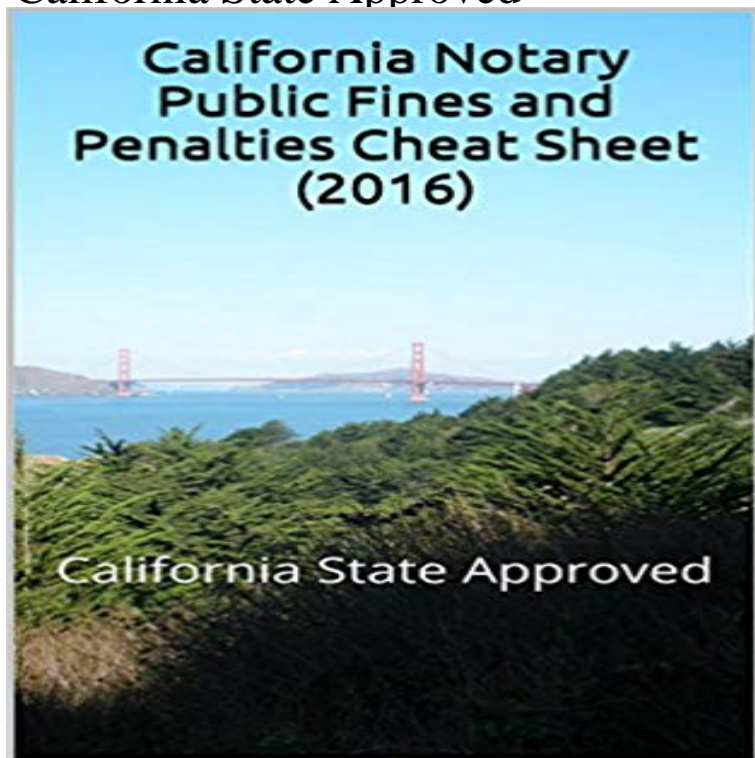


## California Notary Public Fines and Penalties Cheat Sheet (2016): California State Approved
