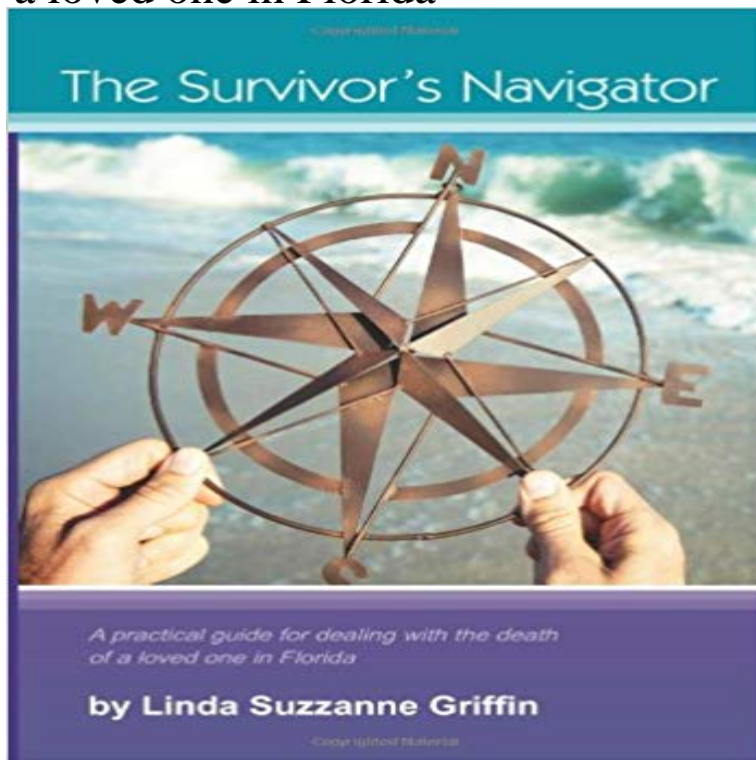


The Survivors Navigator: A practical guide for dealing with the death of a loved one in Florida
