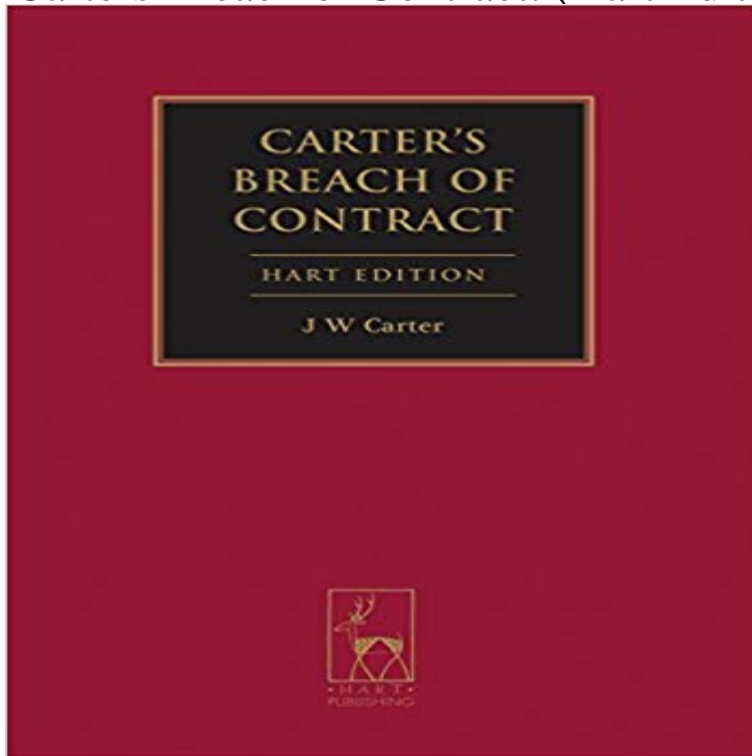


## Carters Breach of Contract: (Hart Edition)
