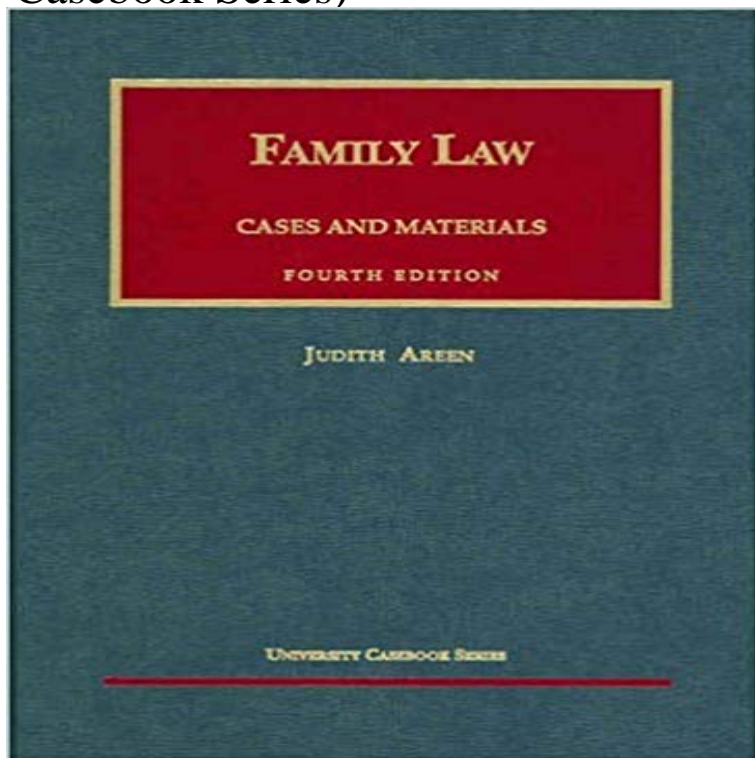


## Cases And Materials On Family Law, Fourth Edition (University Casebook Series)
