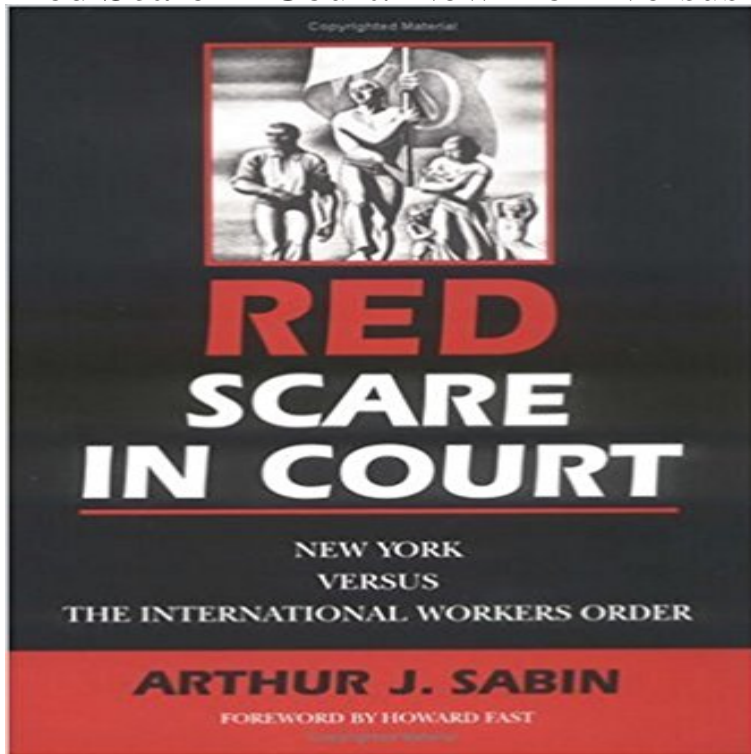


Red Scare in Court: New York versus the International Workers Order
