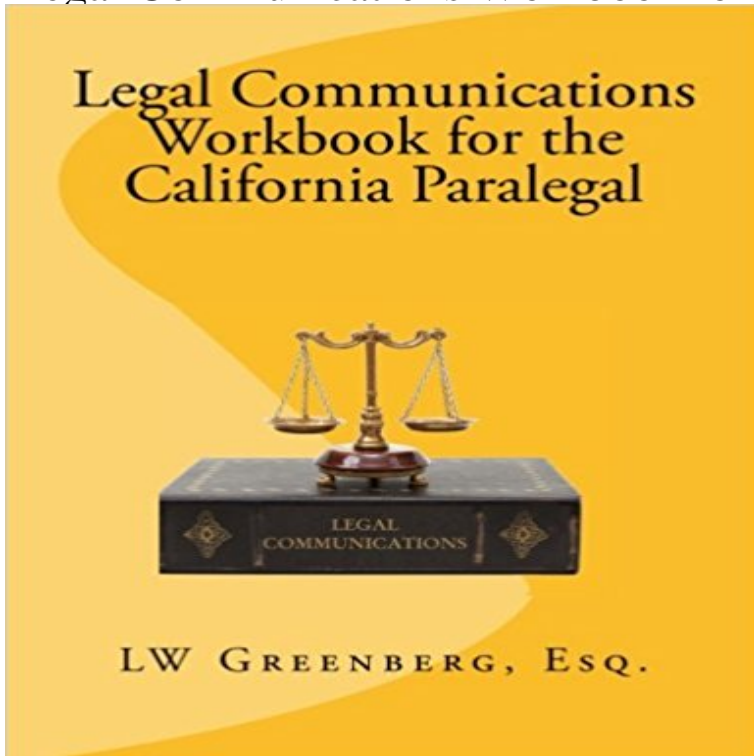


# Legal Communications Workbook for the California Paralegal



This workbook for California paralegals actually teaches the information that paralegals need to know about legal writing. The workbook begins by teaching basic material and then progresses to teach the paralegal the more difficult concepts. There is a step by step process to teach the paralegal how to write a business letter, how to IRAC a case and how to write a legal memorandum. Following each chapter are educational exercises designed to give the paralegal experience performing the tasks described in that chapter. This workbook also contains a special chapter on reading and understanding contracts with educational exercises that provide hands on experience working with contracts and contract laws. There is a chapter that contains the definitions for many legal and Latin vocabulary words; even the differences between IBID and ID are covered in this chapter! This is a great teaching tool that is California specific for the California paralegal.
