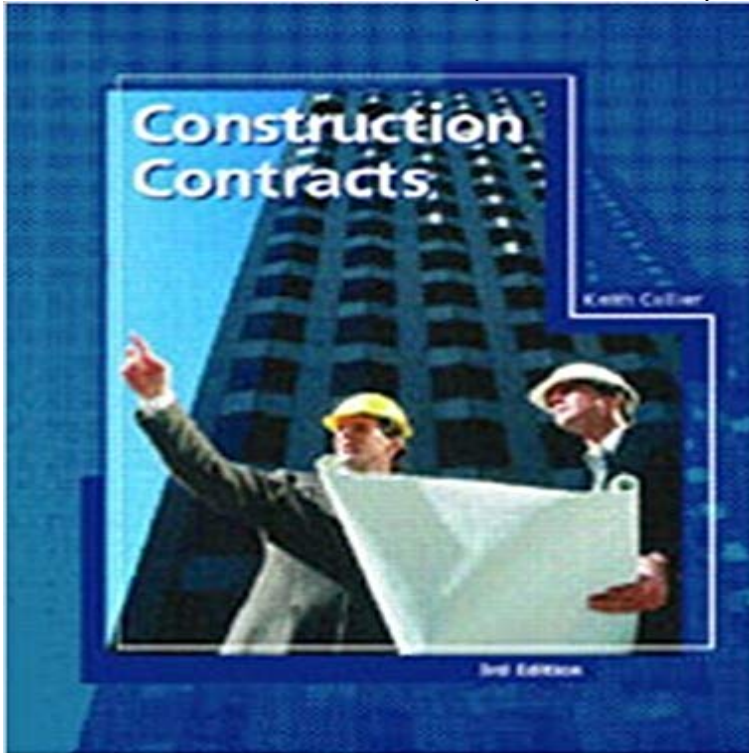


## Construction Contracts (3rd Edition)
