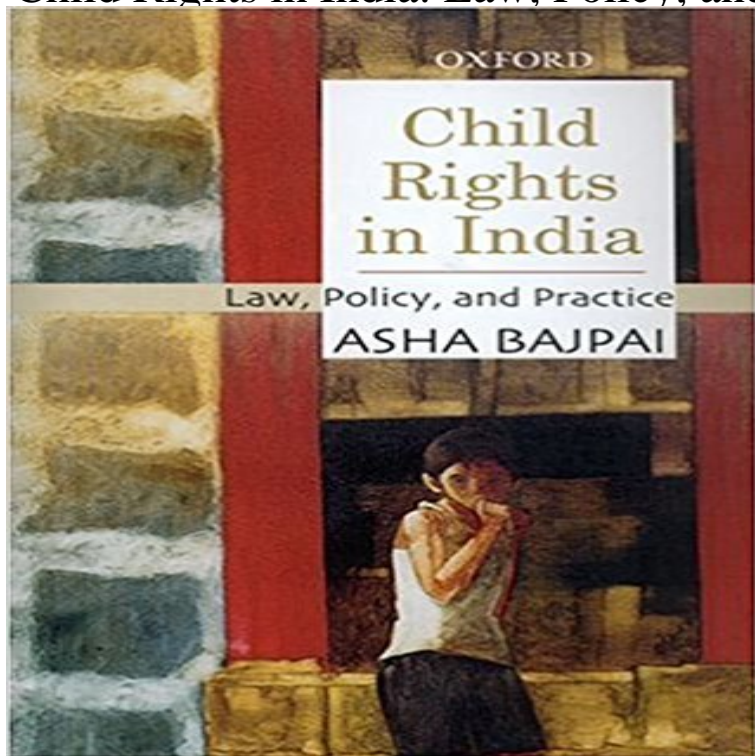


## Child Rights in India: Law, Policy, and Practice
