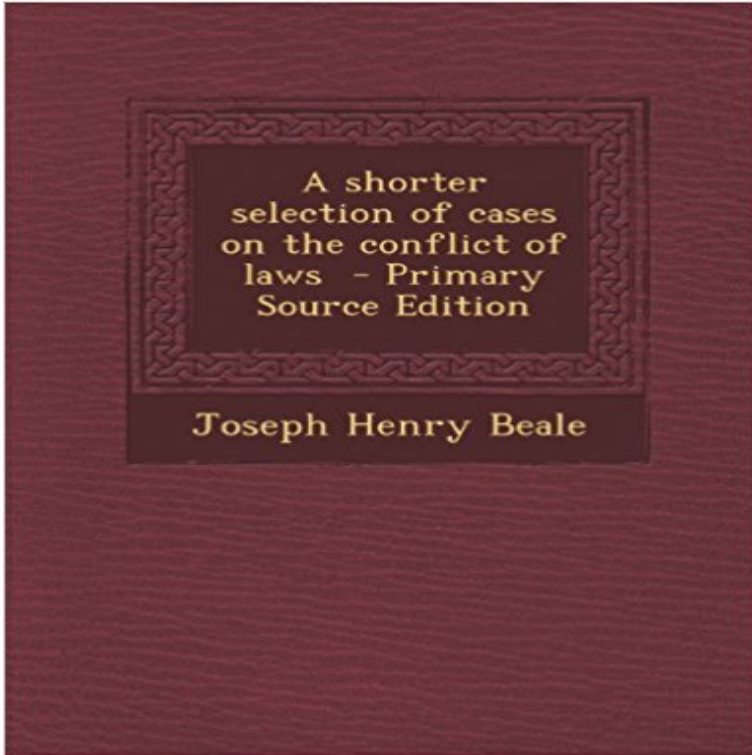


## Shorter Selection of Cases on the Conflict of Laws
