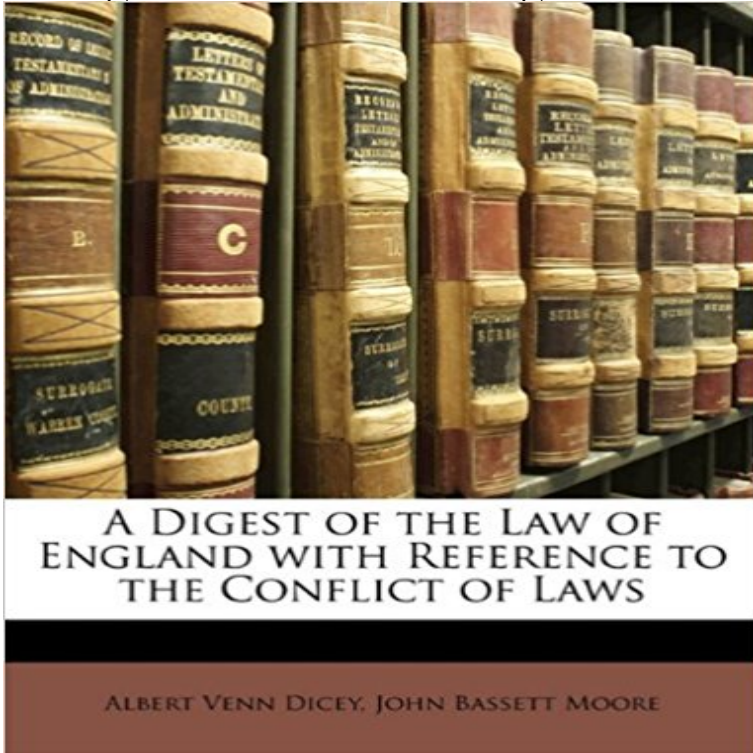


A Digest of the Law of England with Reference to the Conflict of Laws
