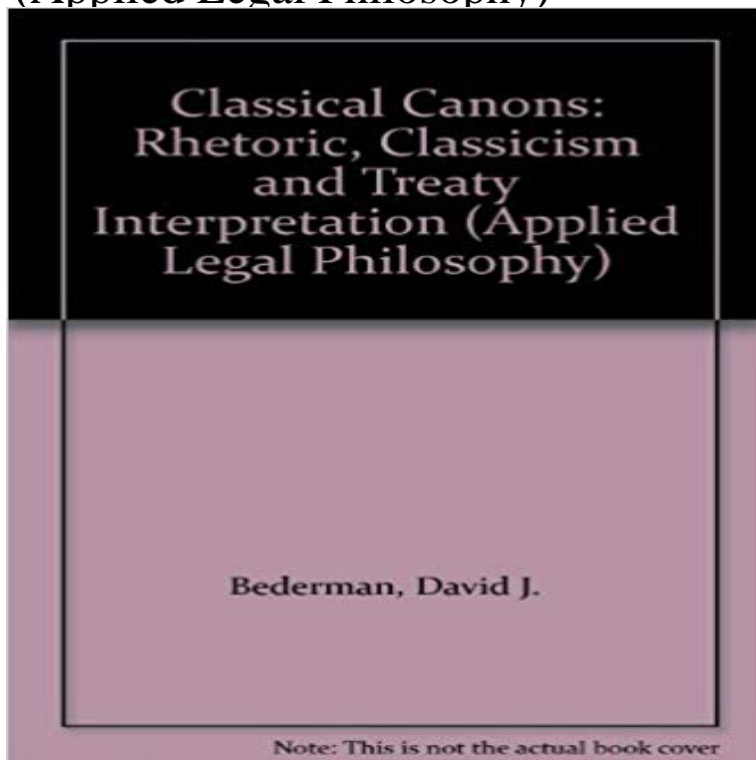


# Classical Canons: Rhetoric, Classicism and Treaty Interpretation (Applied Legal Philosophy)
