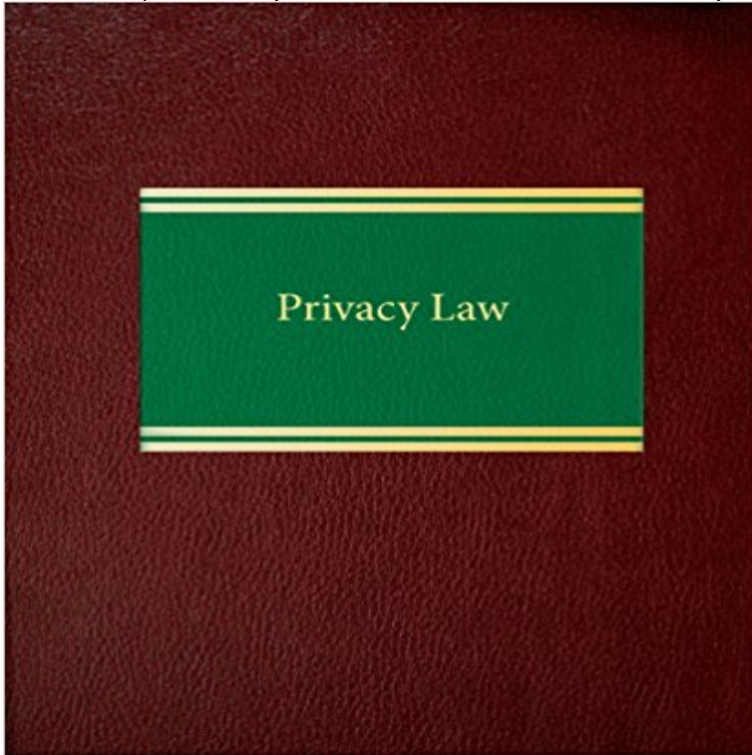


## Privacy Law (Data Protection Series)
