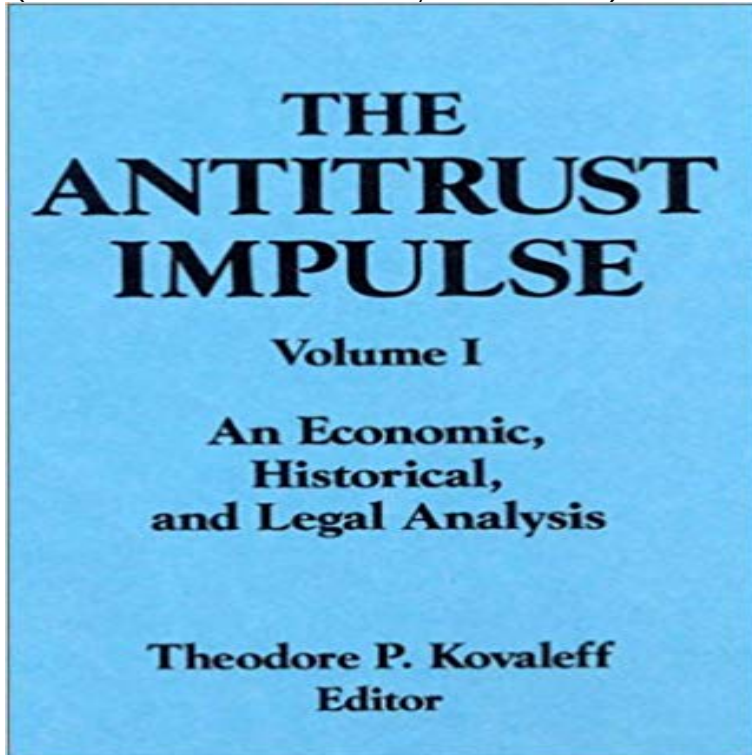


Antitrust Impulse: An Economic, Historical and Legal Analysis (Columbia University Seminar)
