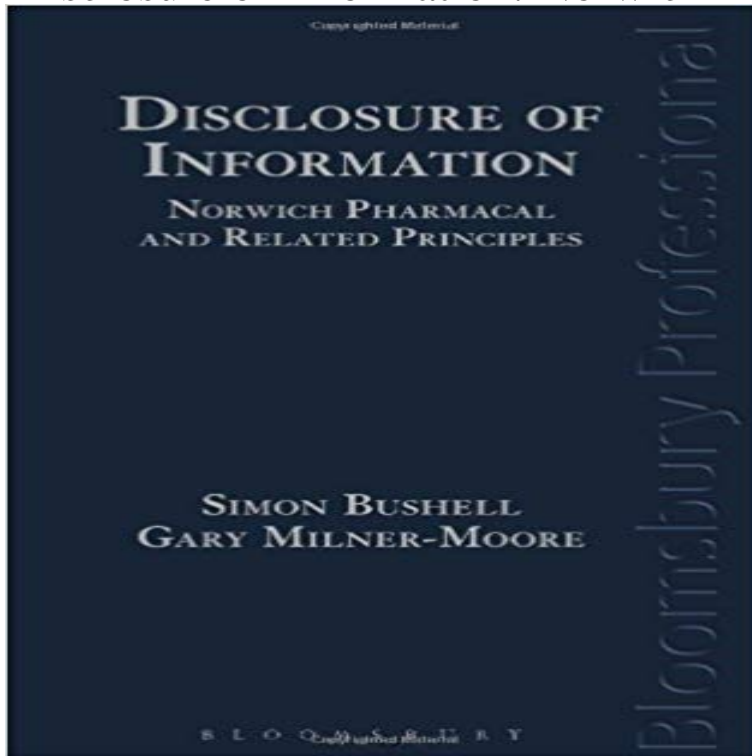


## Disclosure of Information: Norwich Pharmacal and Related Principles

It also contains a detailed analysis of each of the key ingredients dealing with involvement and the mere witness rule; necessity, including the purpose for which the information is required; discretion, including factors such as confidentiality; and the availability of alternative avenues. There are worked examples of when and how the jurisdiction has been invoked in practice, in order to give context to the requirements and an analysis of the extent of the information that can be obtained.
