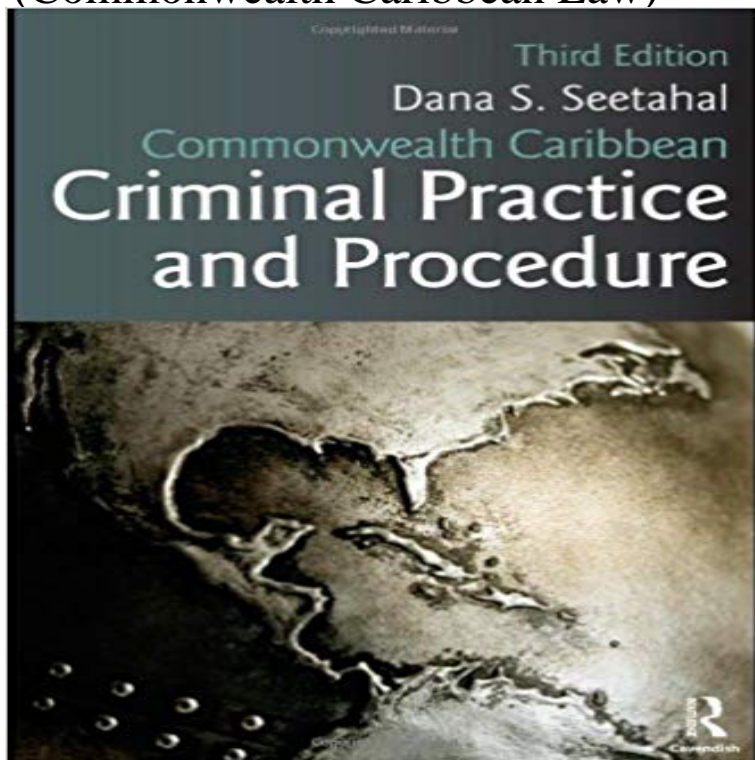


Commonwealth Caribbean Criminal Practice and Procedure (Commonwealth Caribbean Law)
