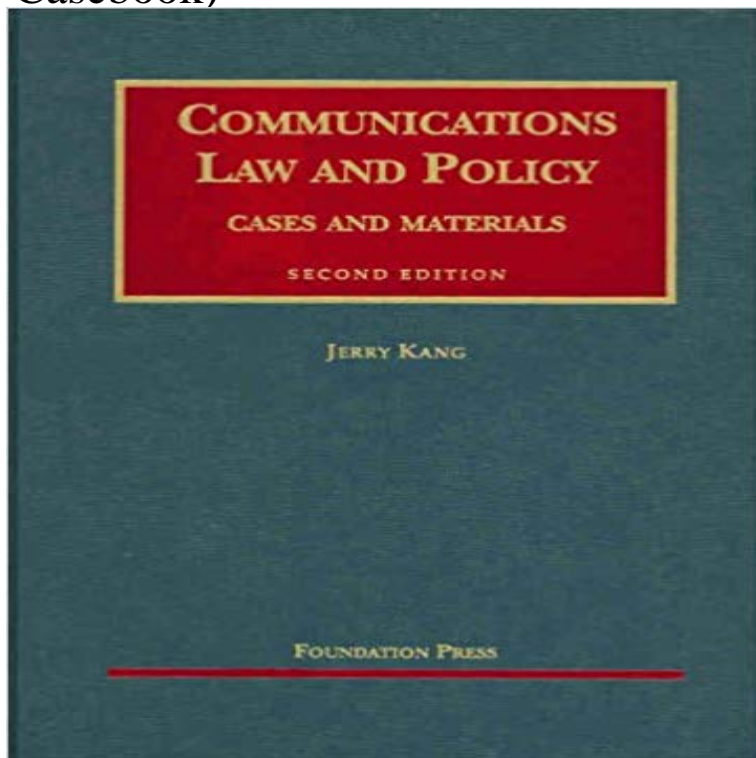


Communication Law And Policy: Cases and Materials (University Casebook)
