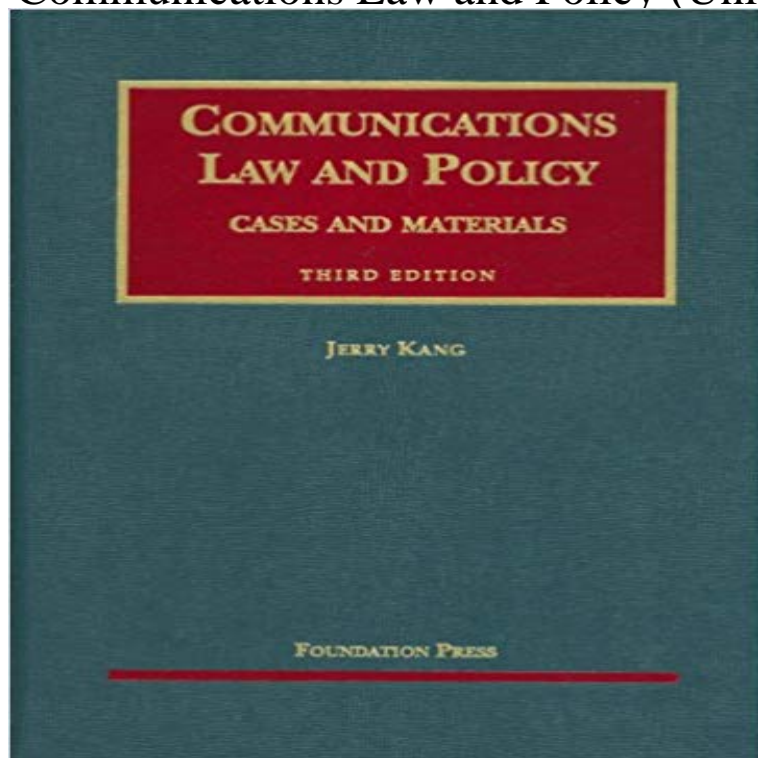


Communications Law and Policy (University Casebook)
