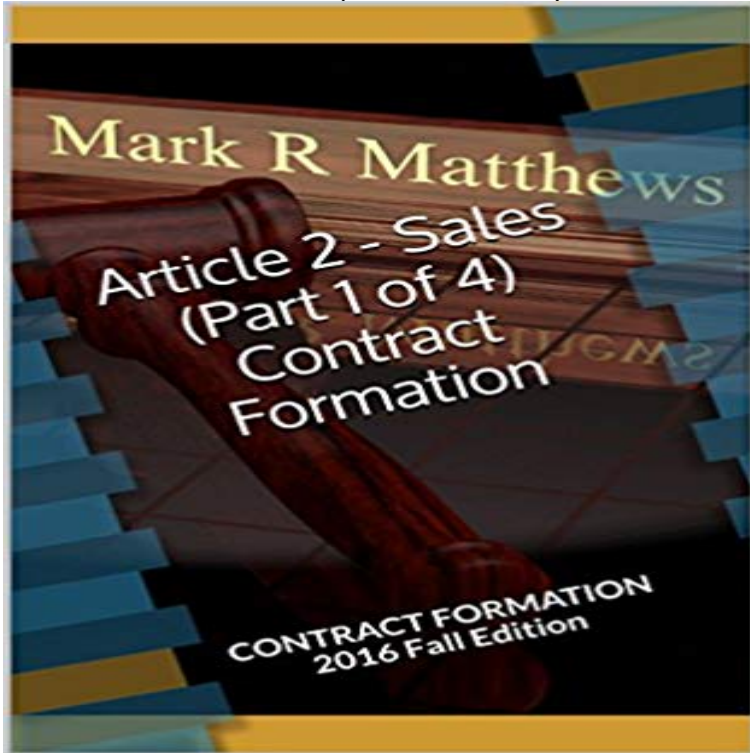


Article 2 - Sales (Part 1 of 4) Contract Formation: 2016 Fall Edition
