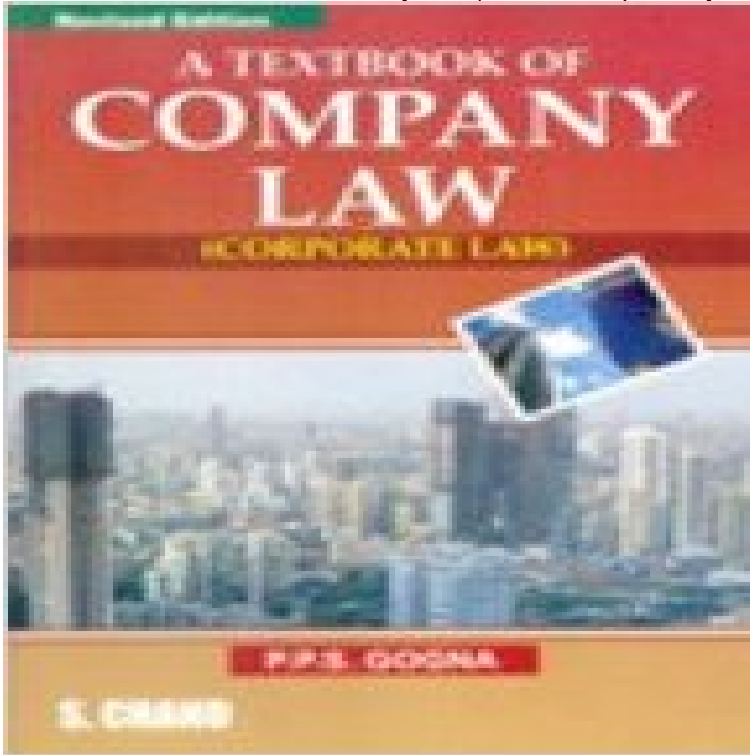


A Textbook of Company Law: (Corporate Law)
