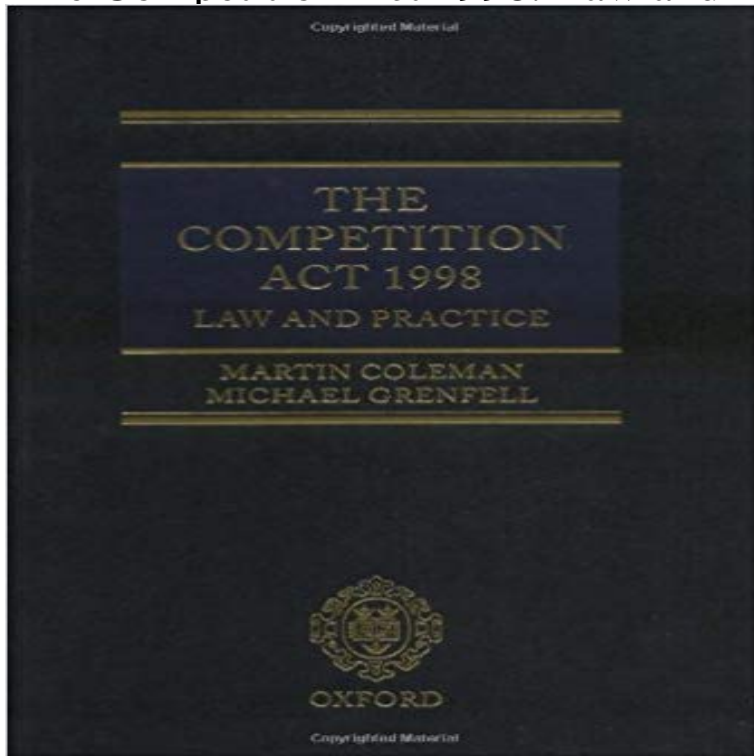


The Competition Act 1998: Law and Practice
