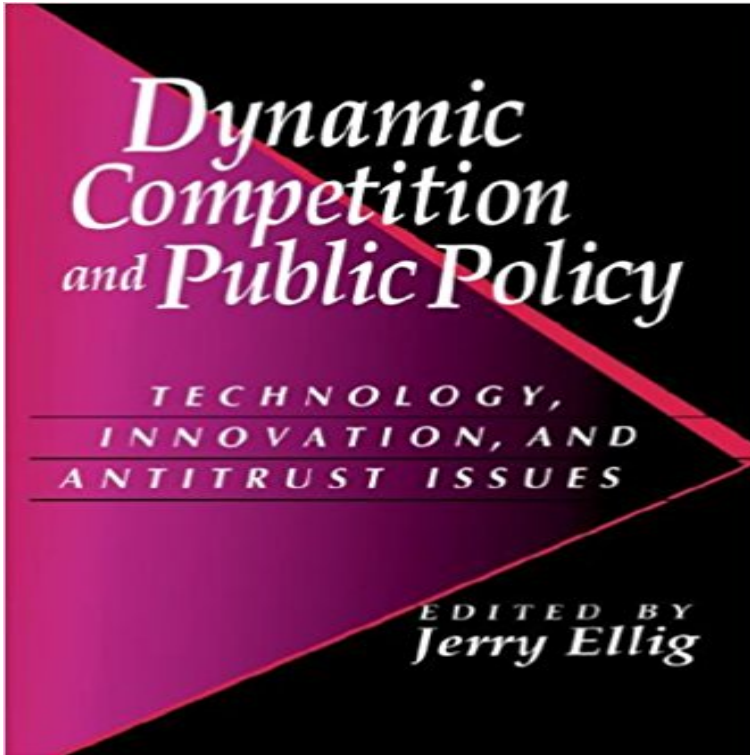


# Dynamic Competition and Public Policy: Technology, Innovation, and Antitrust Issues
