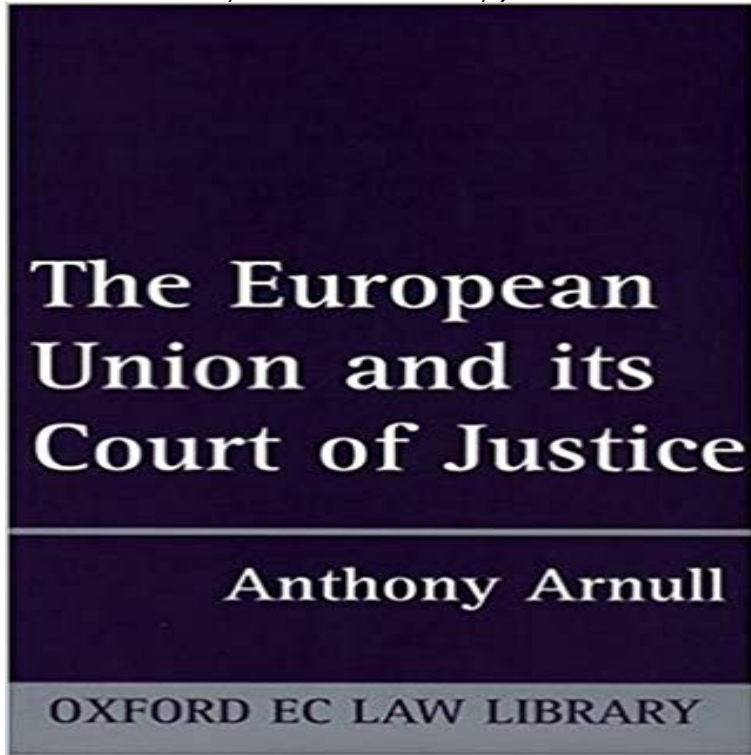


# The European Union and Its Court of Justice (Oxford European Community Law Library)
