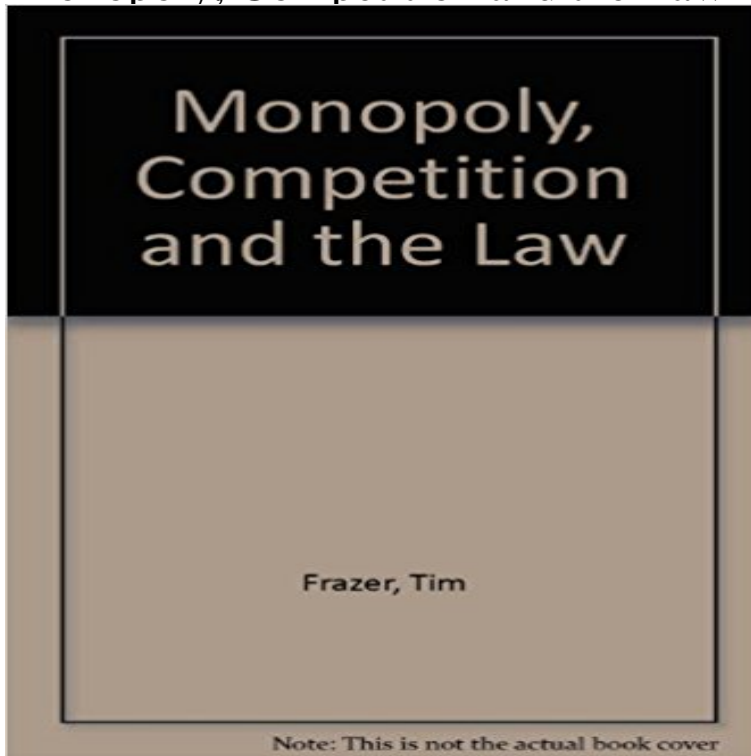


Monopoly, Competition and the Law
