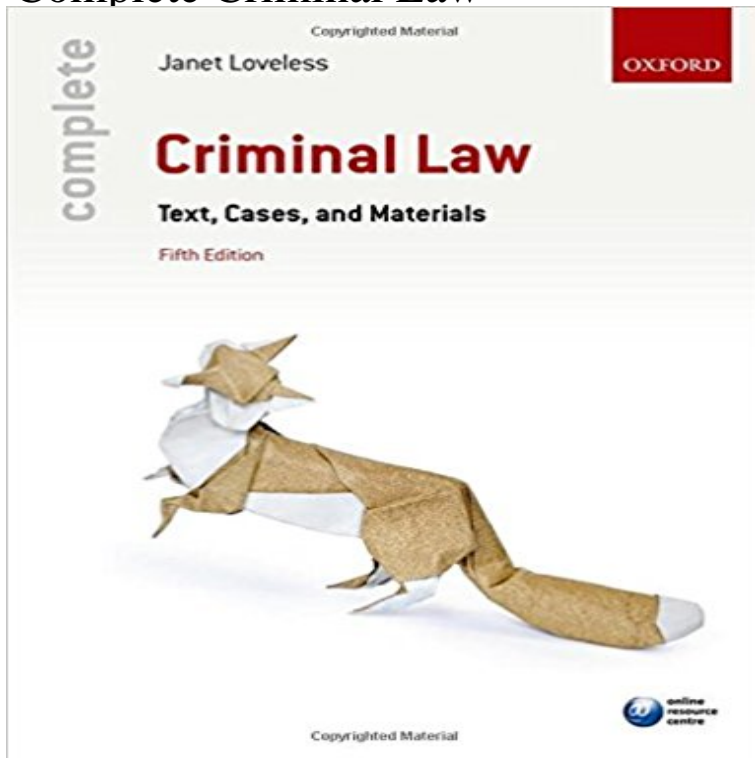


# Complete Criminal Law
