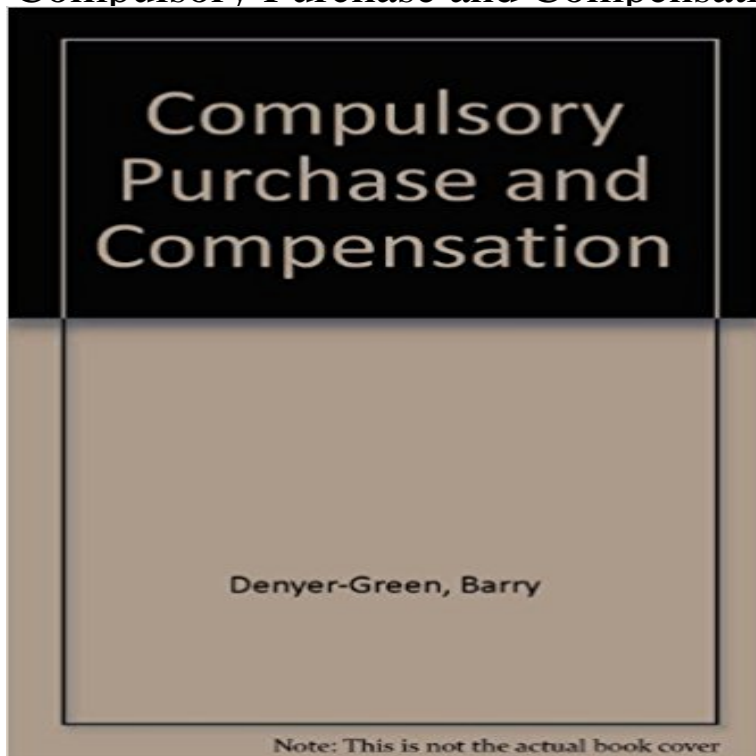


Compulsory Purchase and Compensation
