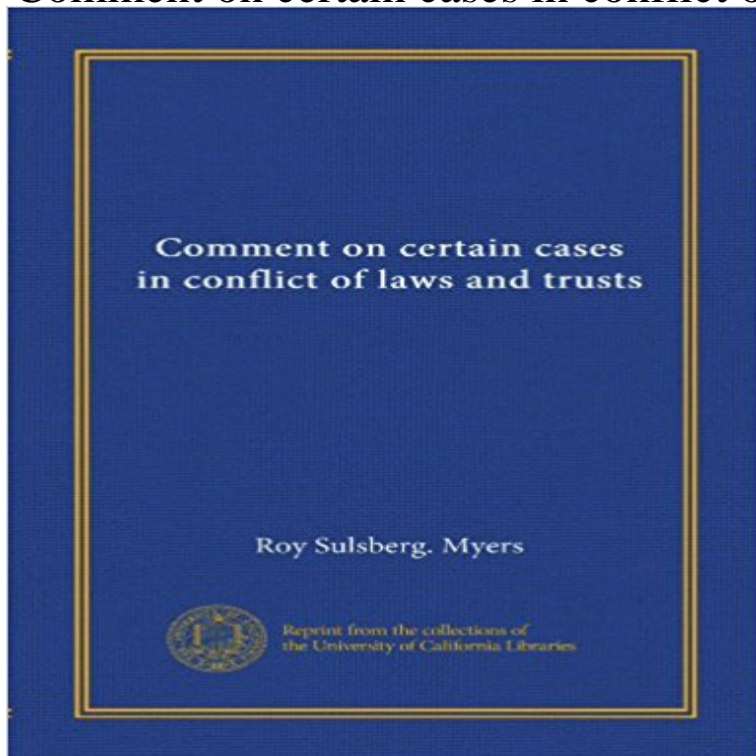


## Comment on certain cases in conflict of laws and trusts
