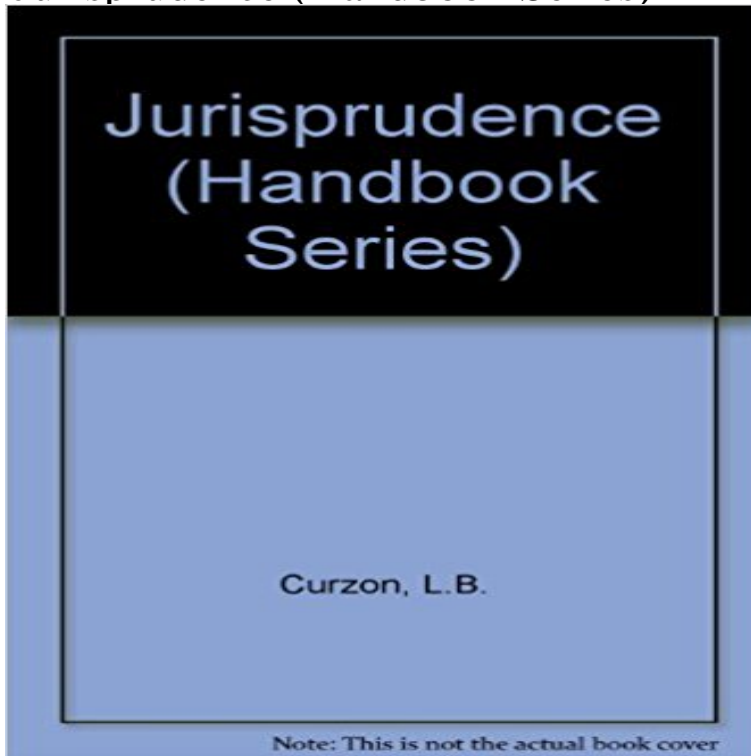


## Jurisprudence (Handbook Series)
