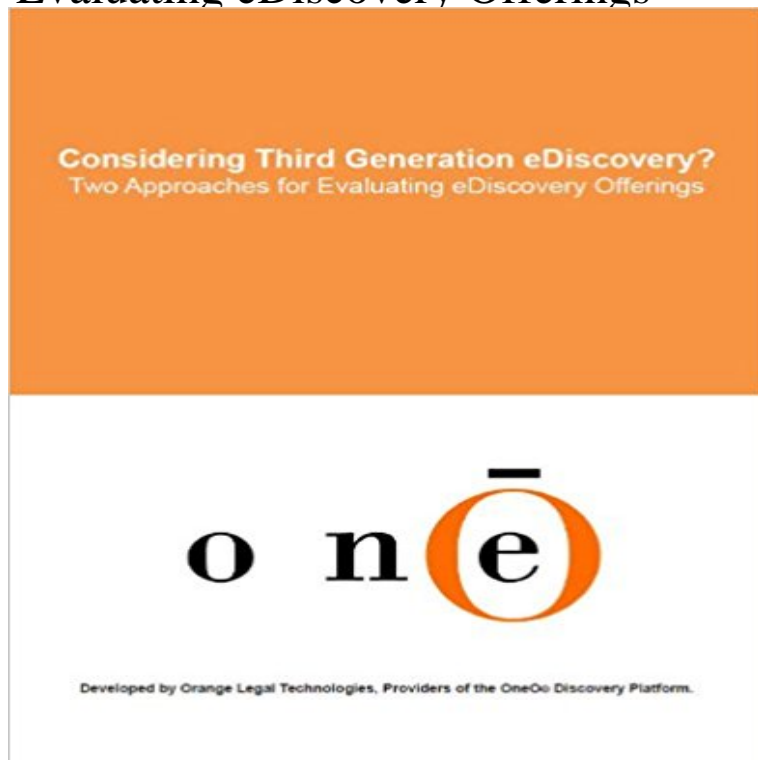


Considering Third Generation eDiscovery? Two Approaches for Evaluating eDiscovery Offerings
