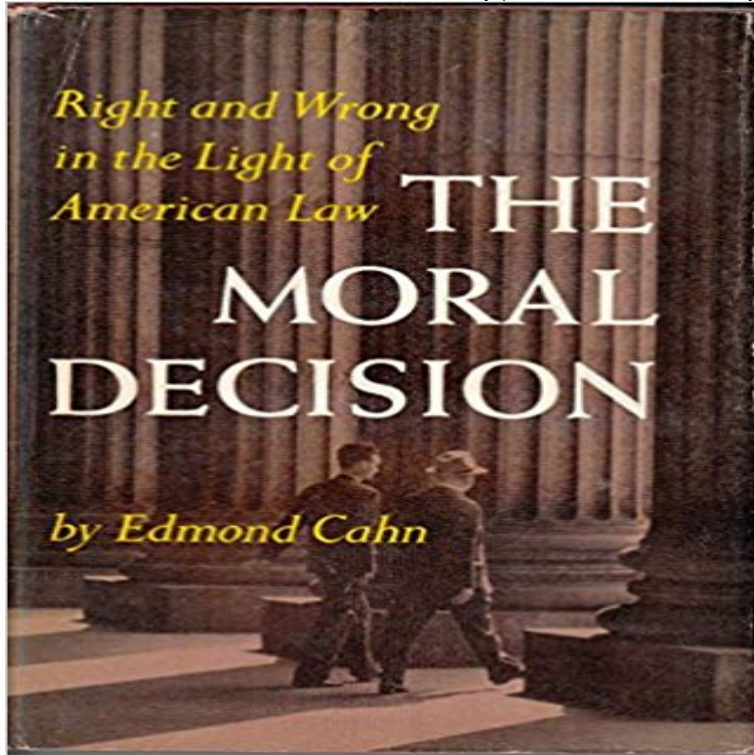


## The Moral Decision : Right and Wrong in the Light of American Law
