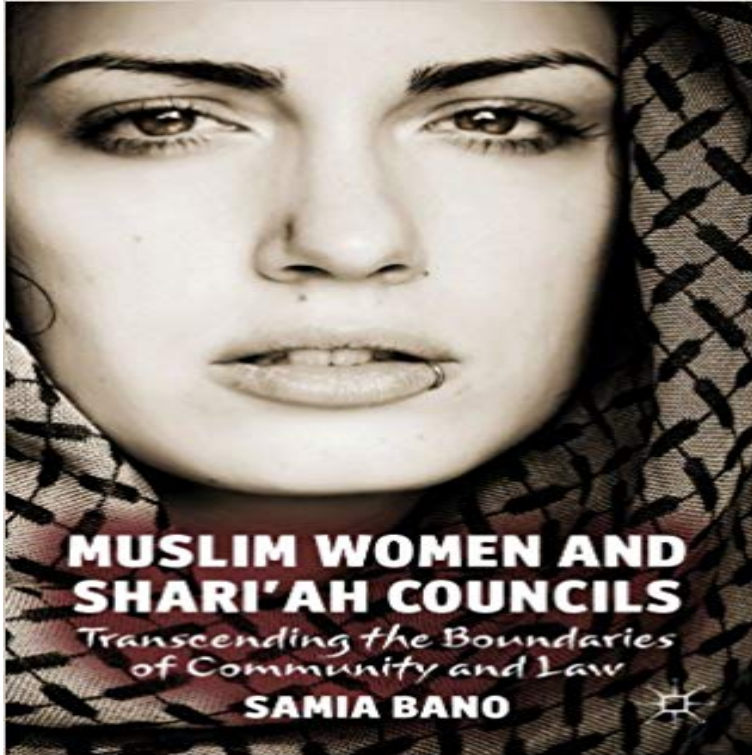


Muslim Women and Shariah Councils: Transcending the Boundaries of Community and Law
