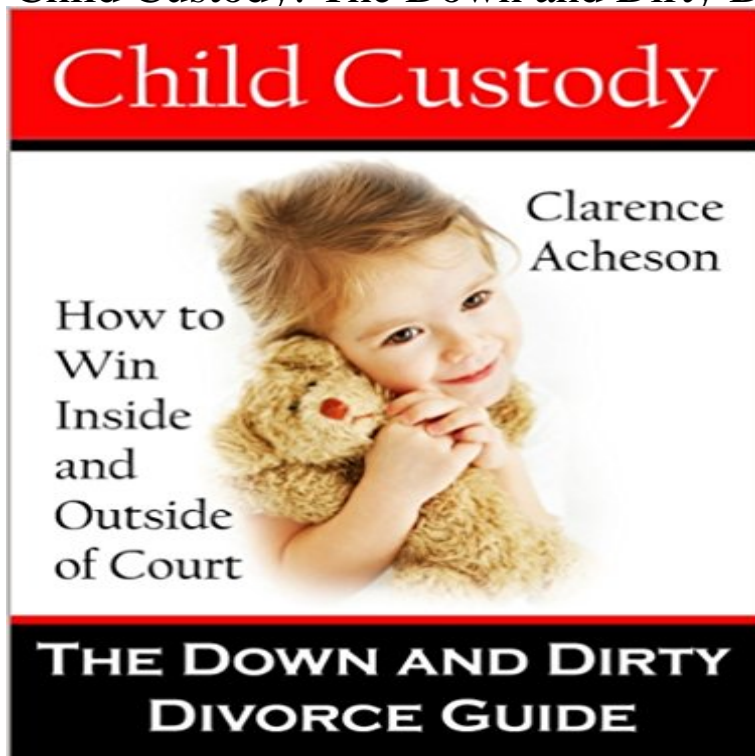


Child Custody: The Down and Dirty Divorce Guide
