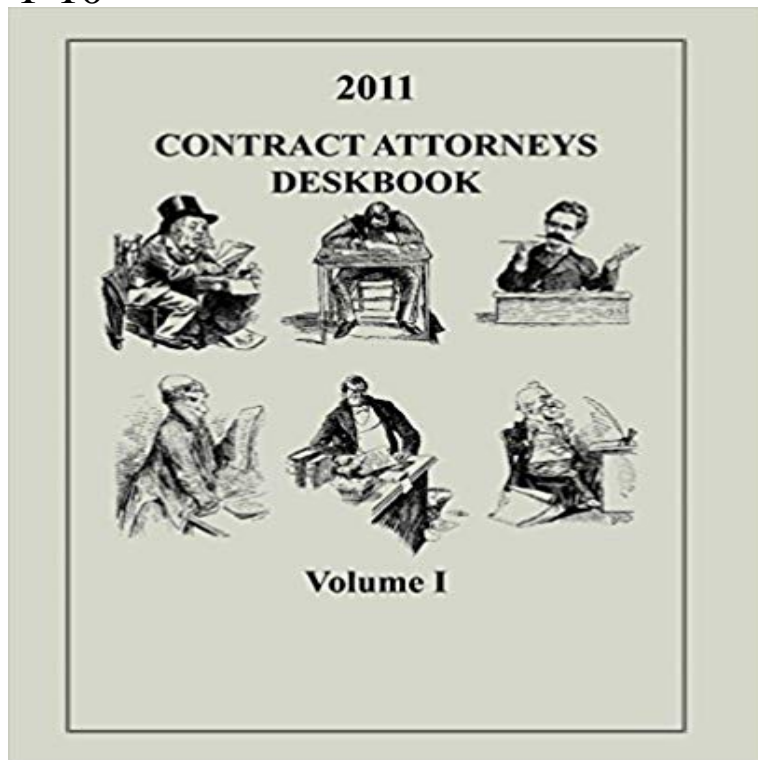


# Contract Attorneys Deskbook, 2011, Volume I: Volume Ia - Chapters 1-10
