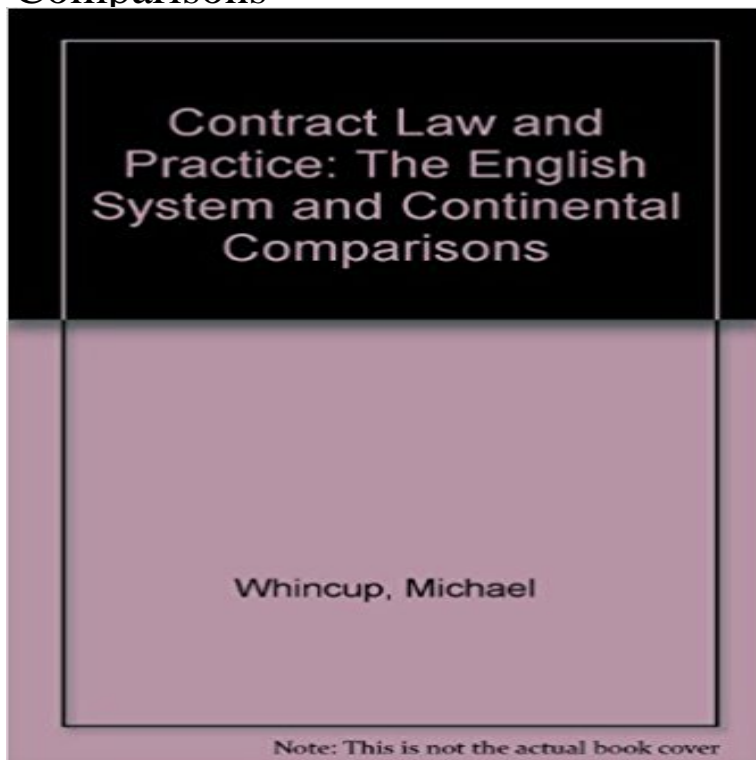


# Contract Law and Practice: The English System and Continental Comparisons
