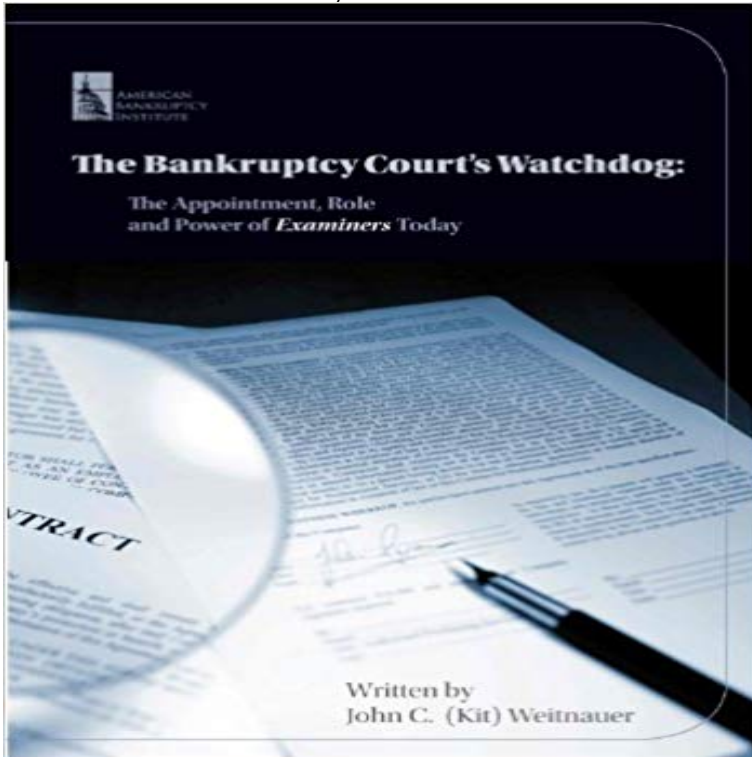


# The Bankruptcy Courts Watchdog: The Appointment, Role and Power of Examiners Today
