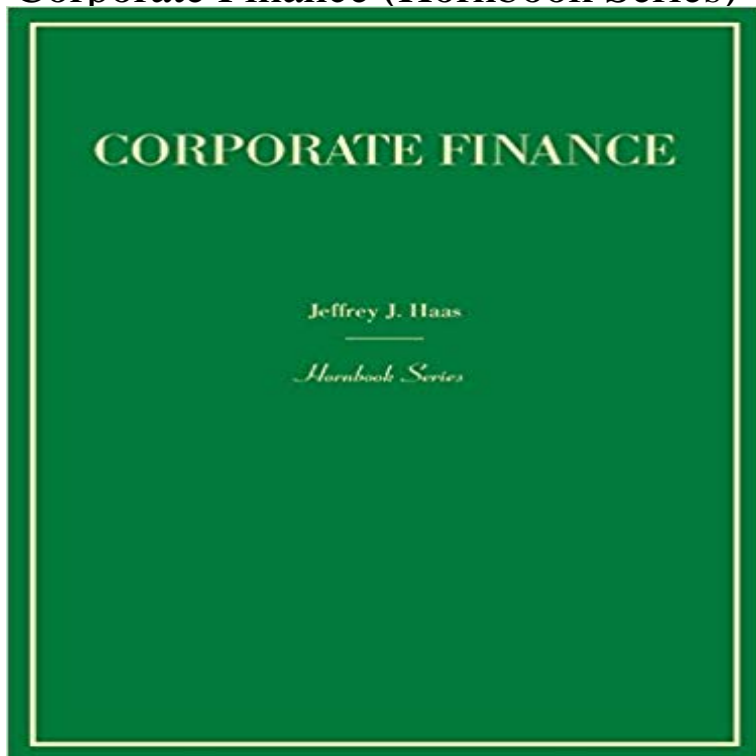


## Corporate Finance (Hornbook Series)
