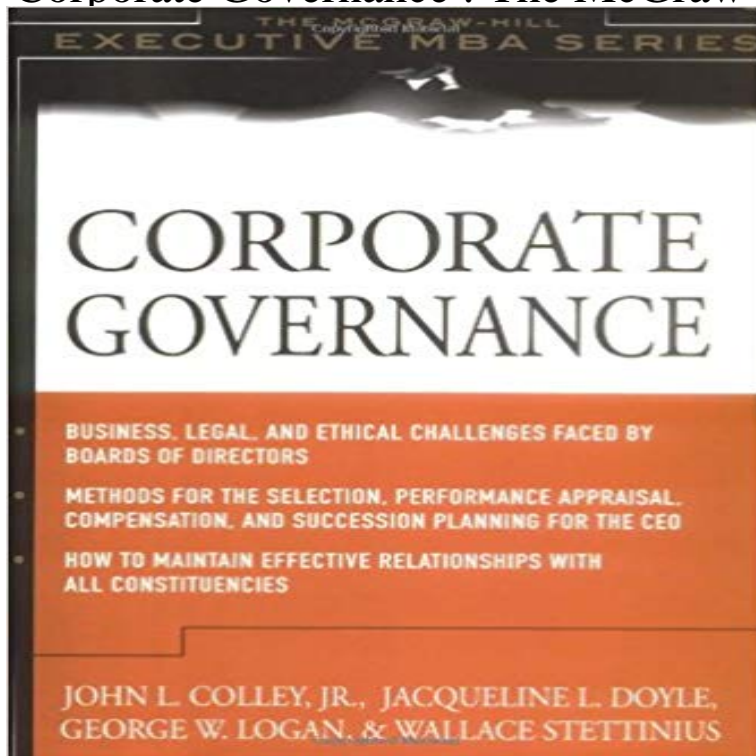


## Corporate Governance : The McGraw-Hill Executive MBA Series
